- Closeout in October
- Filing the paperwork with the state in February

5. ARCHITECT'S UPDATE

Ken Linsley presented:

- Results of structural analysis
- Sloped roofs were questionable for weight bearing Like to see 8 lbs. per ft. they were coming in @ 7 lbs. per ft. Same issue with the gymnasium
- Engineers went back to supplier looking for a lighter PV and there is a lighter one
- Shared a drawing with placement of the PV's on the roof
- PV's will provide pproximately 30% energy savings

- Next meeting there should be completed documents for approval
- Architectural documents are approximately 80% complete
- EPDM roofing membrane recommended to use a white membrane for PV use. The white is difficult to get as it is slowly being taken off the market
- Reached out to manufacturers black roof will not be a problem

Roger Rousseau made note we will need City Council to award the contract for the contractor and wants to ensure we are diligent with our schedule. Tim Callahan will review the dates and discuss schedules further
